Puerto Rico currently has its own government but is a territory of the United States. There have been many people who have fought for Puerto Rico to become a state, but others are against it.

People who believe that Puerto Rico should become a state give many reasons. They believe Puerto Ricans should have full rights (voting, welfare, etc.) because they pay taxes to the United States and many serve in the U.S. army. They have supported the United States as a colony for over 100 years. Also, the success of Alaska and Hawaii shows Puerto Rico could contribute to our economy by becoming a state.

Other citizens of both the United States and Puerto Rico have concerns. Puerto Ricans do not want to give up their flag and national pride. The U.S. flag would have to change to add a 51<sup>st</sup> star and the U.S. government would have to change to add Puerto Rican representatives. They also are worried about admitting a state where only 20% of people speak English (even though it is the official language).

Puerto Rico is likely to stay a U.S. territory until all sides agree. Because of the strong opinions, this may not happen for a long time.

# Passage:

While voting in the United States is optional, there are 32 countries where it is required. If people in these countries do not vote, they must pay a fine. Australia is one of these countries. 90% of Australian citizens vote, while the highest percent of U.S. citizens that voted was 64% for the 2008 Presidential election.

The United States might be better off with a required voting system. The idea of a democracy is that all citizens choose their government. The only way to get politicians to care about all citizens is if they all vote. It could make a greater part of the country educate themselves on the government. Finally, requiring everyone to vote means no groups will be left out.

A recent national survey showed that 70% of Americans are against required voting. Many believe it is against the idea of democracy to force them to vote. If forced, some may go to vote but not care who they vote for (or they may protest or slow down the system). Also, the punishments would be difficult to enforce. Finally, the system does not account for people who are sick, away, or do not like either candidate. Fining these people would be unfair and may cause them to resent the U.S. government more.
